I AM A CURRENT STUDENT AT THE UNIVERSITY OF CAMBRIDGE, AND I AM EXPERIENCING FINANCIAL DIFFICULTIES; IS THERE ANY SUPPORT AVAILABLE?

It may be that, at some point during your studies, you might find yourself in financial difficulties which have arisen as a result of unexpected or sudden changes in your circumstances. In this case, you can discuss your situation with a variety of people from both the College community and the University.

In College, you can access support from your Tutor, Senior Tutor and, in some colleges, a Student Finance Officer or equivalent.

If you are a postgraduate student, you might also find it helpful to speak with someone in your department which could be, for example, an administrator or your Supervisor.

In addition to any financial hardship support the University can offer, some students may be eligible for extra help from the government. You can find information about any financial support you may be eligible for from the government in the 'Student Finance' section on their website: www.gov.uk/student-finance/extra-help.

HARDSHIP FUNDING FOR UNDERGRADUATE STUDENTS

Hardship funding for undergraduate students is provided by the Bell, Abbott, and Barnes Funds, which provides grants of up to £2000 per year. The application deadlines are in the middle of each term. College tutors apply on behalf of students, as such the University suggests that students should speak with their Tutor as soon as possible to ensure they meet the deadlines for applications. If you are a care leaver or estranged student you may apply for support during the first 10 weeks after graduation.

SHEIKH FAMILY BURSARIES

The Sheikh Family Bursaries provides financial hardship assistance to undergraduate Muslim home students from all Cambridge colleges. The maximum award is £2000 per year and applications are submitted by the College on your behalf. For more details, to access an application form and eligibility criteria please visit this link:

HARDSHIP FUNDING FOR POSTGRADUATE STUDENTS

As a postgraduate student, the University expects that you will have budgeted for the duration of your studies; however, in circumstances where you find yourself in financial hardship as a result of unexpected changes in your financial situation, you might be able to access the University's Postgraduate Hardship Fund. Although you can submit an application yourself, you are advised to discuss your concerns with your Postgraduate Tutor who should be able to advise you of the options available in your situation. You can also discuss your circumstances and explore your options with the Student Advice Service. The awards are normally no more than £2000. ASSISTANCE WITH MEDICAL COSTS (CRANE'S CHARITY)

Crane's Charity is a fund available to students at the University of Cambridge who need treatment for physical or mental illness which cannot be obtained under the NHS.

Examples of when funding might be provided include:

- medical, surgical, or psychiatric treatments
- items associated with such treatment (for instance, nursing home, convalescent accommodation, travel etc.)
- treatment for injuries resulting from accidents

Although you might wish to discuss your financial situation with your College Tutor, you can submit the application yourself.

Intermitting students are also eligible to apply for financial support from Crane's Fund.

SPECIAL HARDSHIP FUND

This fund has been established for both undergraduate and postgraduate students who:

- are intermitting and who have no other available financial support
- 'have incurred UK hotel quarantine costs to Cambridge for the academic year 2021/22 to commence/continue their studies which has put them into financial hardship'
- are on a Year Abroad

NOTE: Information about eligibility for this fund (e.g. intermitting students and students affected by COVID-19) is correct at the point of writing - January 2022. Although you might wish and are advised to discuss your financial situation with your College Senior Tutor, you can submit the application yourself.

CAMBRIDGE UNIVERSITY PGR COVID-19 ASSISTANCE SCHEME (PGR CAS)

This fund is available to Postgraduate Research self-funded students in their final year of study, and whose work has been affected by COVID-19. The aim is to support those students who have had to delay submitting their dissertation and who have had no opportunity to receive extended funding. The funds available are up to £3700. Applications submitted in Lent and Easter terms 2022 are subject to funding availability.

You are advised to speak with your Supervisor and College Tutor before making an application.

STUDENT HARDSHIP LOAN FUND (LISTED AS 'LOAN FUND I' IN THE UNIVERSITY STATUTES AND ORDINANCES)

In exceptional circumstances, where all other options have been exhausted and depending on your individual situation, you might be able to apply for an interest-free loan from the Student Hardship Loan Fund. AS A DISABLED STUDENT, AM I ELIGIBLE FOR ANY DISABILITY-RELATED FINANCIAL SUPPORT?

Disabled students are advised to register with the Disability Resource Centre (DRC). The DRC is the University's disability service, providing advice, information and support to disabled students. Disabled students can apply for assistance with medical expenses from Crane's Charity (please see above information and links to it), however, they would normally be expected to seek assistance with disability-related costs through the Disability Resource Centre. Nonetheless, applications relating to disability will be considered on a case-by-case basis; assistance may be provided, for instance, where the student has acquired a disability since matriculation and where no other financial support is available.

I AM INTERMITTING; IS THERE ANY FINANCIAL SUPPORT AVAILABLE TO ME?

If you are intermitting and find yourself in financial hardship, you can apply for funds from the Special Hardship Fund:

If you are a postgraduate student and are intermitting or thinking about intermitting your studies, speak with your Research Funding Council (where applicable) about your situation as there could be financial implications.

If you are an undergraduate student and are thinking of suspending your studies due to compelling personal circumstances, such as ill-health or bereavement, the Student Loans Company will consider each case individually and 'do what [they] can to help the student get funding for future study.'

Funding for eligible undergraduate students is calculated as the length of current course + one year. For example, if you started your course and intermitted your first year of study, when you resume study, you will be able to use the '+ one year' to fund the academic year of your return from intermission. In some circumstances, a student might intermit their study twice. If that is the case and you need to access funding for a second time, you would have to meet the eligibility criteria for compelling personal reasons. You are expected to provide evidence of compelling personal reasons, which depending on your circumstances, this could include for example but not limited to: medical evidence from your GP, evidence from social services and evidence from the University and/or College.

Intermitting students, undergraduate and postgraduate, who are experiencing financial hardship could apply to the SFE's financial hardship fund provided they have had their application for student support approved. This funding can be exceptionally extended to intermitting students. Continuing undergraduate students who intermit for health reasons at the beginning of the academic year and the University has informed the student loan company of this, will automatically have their payments extended for 60 days without the need for an application for hardship.

Intermitting students can access financial support with medical expenses through Crane's Fund. Please see the information above.

I AM AN INDEPENDENT (ESTRANGED) STUDENT. IS THERE ANY FINANCIAL SUPPORT I CAN ACCESS?

If you are an undergraduate student independent or estranged from your biological or adoptive parents, you may be eligible to apply for Estrangement Status with Student Finance in England, Wales or Scotland. The process for making applications for estrangement status, including further information on eligibility and evidence requirements, can be found in the Stand Alone Student Finance Guide (www.standalone.org.uk/guides/student-guide/). This guide was created in partnership with Student Loans Company Ltd and Student Awards Agency Scotland.
