OVERVIEW

Purpose:

Data Usage:

Your responses will be used to shape how the SU improves its services, activities and communications. Your data will be stored securely and will only be accessed by authorised personnel. It will be deleted upon completion of the analysis.

Privacy:

Your responses will be kept confidential. We will not share your personal information with any third parties.

Voluntary Participation:

Participation is voluntary, and you can withdraw from the survey at any time.

Intellectual Property:

The survey and its results are the property of Cambridge Students' Union.
